Review Tool Status Update - #3

What's been fixed?

- 1. Annotation Error.** Clerks should no longer receive "an error occurred saving the document annotation" message when accepting filings after adding annotations or manual stamps.
- 2. Annotation Options.** Extra annotation options, including stroke, fill, and transparency, have been removed from the interface as they were not supported by the system.
- 3. DOB Date Format.** Ghost text has been added to avoid data entry errors.
- 4. Document Description.** Edits made to the document description field now save and transmit to Odyssey.
- 5. Document Loading.** Adjustment made to help improve document loading times (or document not loading at all) in the review tool.
- 6. Draw Line.** Clerks can now add 1 pt. black lines to documents as needed for strikethroughs and underlines and have them correctly save to their documents as expected.
- 7. Export Review History.** Clerks will now be able to export an Excel spreadsheet of the information that is displayed on their review history screen using the Export button.
- 8. Font Size.** Default font size is 12pt, per Supreme Court Rule 1-100
- 9. Judge Name Column.** The assigned judge name now displays in the Judge column in the Review Queue display for subsequent filings.
- 10. Process Payment Failed.** This error should no longer process incorrect values.
- 11. Receipted Filing.** Users can now receipt filings
- 12. Signatures and Seals.** Image stamps can be moved or deleted after being applied
- 13. Text Formatting Options.** Instead of the palette icon, both free text and text stamps can be formatted using a new drop down in the annotation toolbar.

14. **Text Stamps.** Are no longer burned in upon End Review and can be manipulated until the Accept button is pressed.
15. **Text Tool.** Text entries, font size, and placement are holding their position upon transmitting to Odyssey
16. **Times New Roman.** Resolved issues with some fonts not being recognized by the application, which resulted in errors.
17. **View Envelope Details.** From the Review Tool use the waffle icon to go to "[OFS Website – Filing Search](#)" to search for the case number or envelope number

What's still broken?

1. **Appellate Fields.** Initial filings at the Court of Appeals and the Supreme Court have two required fields that have to have an entry before the envelope can be reviewed
2. **Copy Docket Date.** Not holding the copied docket date on a re-submitted envelope
3. **Courtesy Copy.** The courtesy copy field is not developed yet
4. **Court Admin.** Cannot modify users, add new users, add new attorneys, add a payment account, modify the firm information, or reset a user's password (Tyler will do this for NM for now)
5. **DOB Field Error.** The DOB must be xx/xx/xxxx or you cannot proceed, but there is no error message or visual hint (ghost text has been added as an interim measure)
6. **Documents.** Hyperlinks to the file stamped copy in the Review Tool and the notification are not working. Filer can see their file stamped copy via their Accepted folder, court user can use the "OFS Website – Filing Search" access to envelope details or Odyssey.
7. **Envelope Display.** All parts of the screen must load before the envelope can be worked
8. **Export.** Cannot export results on any page of the Review Tool (except Review History)
9. **Manual Case Number.** On initial filings the field to enter a manual case number is displayed on the Accept Comments fly out window and should not be there
10. **Personally Identifying Information.** The fields for PII in HTML5 do not match the fields in the Review Tool.
11. **Print.** Cannot print the document during review (workaround is taking a screenshot to print)
12. **Reject = Return.** The language throughout F&S is inconsistent and should be "Return"
13. **Review History Sequence.** The sequence of the envelopes in the review history screen are not sorted by most recent
14. **Review Queue Display.** Review Queue columns are not expandable
15. **Rotate.** The rotate document tool has not been developed yet
16. **Service Contact Display.** The email of the service contacts is not displayed in the Serve breadcrumb area or the envelope details
17. **Service Contacts Display.** The Service Contact section of the envelope details has not been developed yet (use the HTML5 filing search option from #5 in the green section above)
18. **Signatures and Seals.** Image stamps (signatures and seals) for some staff are showing "no image found" (this is being resolved user account by user account)
19. **Stamps.** Image stamps that are resized or repositioned do not hold their new orientation or size
20. **Stamps.** Text stamps land in the center of the document instead of where your cursor is (this will not be fixed by Tyler)
